Privacy Policy

This policy applies to information held about clients and prospective clients, suppliers and prospective suppliers, artists, contacts and all other persons about whom Eykyn Maclean holds information. By 'information,' we mean personal information about you that we collect, use, share and store.

In this policy, "we," "us," and "our" means Eykyn Maclean Ltd (Eykyn Maclean), a company registered in England and Wales with No 6771315, registered office 130 Wood Street, London EC2V 6DL and "you" means the individual to whom the information relates. Eykyn Maclean is the data controller for the purpose of the Date Protection Act 1998.

- 1. Information we may collect about you: We may collect and process the following data about you: 1) Information that you provide by filling in forms on our website your name; email address, telephone number and postal address. 2) Information related to your attendance of, and interest in, exhibition events and art fairs. 3) Information about you that you give us in person at our events and art fairs, by filling in forms on our site www.eykynmaclean.com (our site) (e.g. the contact us section or to sign up to our mailing list) or by corresponding with us by phone, e-mail or otherwise and 4) Information in relation to your purchase of our art work or use of our services.
- 2. How we collect information about you: 1) Collecting information you give to us when you purchase any art work or visit us at each art fair; 2) filling in our online form to join our mailing list
- **3.** Uses made of the information we collect: We use your information to: 1) provide information about our art work and services to you; 2) keep you informed about art work, artists and events that we think you may find interesting 3) carry out our obligations arising from any agreements entered into between you and us; 4) communicate with you; 5) for administration and maintenance of the Website; 6) comply with legal and regulatory obligations; and for security and to check your identity.
- **4. Legal basis for processing:** Our processing of your personal information is necessary: 1) for the performance of contracts to which you will be a party to and in order to take steps at your request prior to you entering into those contracts; 2) for the purposes of legitimate interests pursued by us; or 3) in order to comply with a legal obligation to which we are subject. 4) In relation to any processing of special categories of personal data, we will generally rely on obtaining specific consent from you at the time unless there is otherwise a legal requirement for us to process such information.
- 5. Legitimate interests: 1) Where our processing is based on the legitimate interest grounds described above, those legitimate interests are: (i) collecting personal information to provide you with a smooth and efficient client experience; (ii) to make sure you receive updated information on Eykyn Maclean's business activities; (iii) to provide the services you have requested; and (iv) for our own marketing and research.
- **6. Sharing your information:** Except as expressly set out in this policy we will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so. The personal information you provide to us may be shared with third party companies, agents, contractors, service providers or affiliated companies if this is necessary to provide you with our art work or services, respond to your inquiries or for any of the purposes described in this policy.

We may also share your personal information with: 1) law enforcement agencies, other governmental agencies or third parties if we are required by law to do so; and 2) other business entities should we plan to merge with or be acquired by that business entity, or if we undergo a re-organization with that entity.

7. Transferring Your Information outside the UK and Europe: Your personal information may be transferred to, and stored at, a destination outside the European Economic Area ("EEA") and may also be processed by staff operating outside the EEA who work for us, or for one of our service providers.

When we, or our permitted third parties, transfer your information outside the European Economic Area, we or they will impose obligations on the recipients of that data to protect your information to the standard required in the European Economic Area or otherwise require the recipient to subscribe to international frameworks intended to enable secure data sharing. In the case of transfers by us, we may also transfer your information where: (i) the transfer is to a country deemed to provide adequate protection of your information by the European Commission; or (ii) where you have consented to the transfer.

8. Your Rights: At any time, you have the right: 1) to request access to or a copy of any personal data which we hold about you; 2) to rectification of your personal data, if you consider that the information we are holding is inaccurate; 3) to ask us to delete your personal data, if you consider that we do not have the right to hold it; 4) to withdraw consent to our processing of your personal data (to the extent such processing is based on previously obtained consent); 5) to ask us to stop or start sending you marketing messages as described below in the marketing section; 6) to restrict processing of your personal data; 7) to data portability (moving some of your personal data elsewhere) in certain circumstances; 8) to object to your personal data being processed in certain circumstances; and 9) to not be subject to a decision based on automated processing and to have safeguards put in place if you are being profiled based on your personal data.

Any request from you for access to or a copy of your personal data must be in writing and we will endeavour to respond within a reasonable period and in any event within one month in compliance with data protection legislation. We will comply with our legal obligations as regards your rights as a data subject.

We aim to ensure that the information we hold about you is accurate at all times. To assist us in ensuring that your information is up to date, do let us know if any of your personal details change at the following email address info@eymac.com.

You also have the option of "unsubscribing" from our mailing list at any time thereby disabling any further such e-mail or other communication from being sent to you by emailing info@eymac.com.

We will action any opt out request from you without delay.

10. How long will we keep Your information? We will only keep the information we collect about you for as long as required for the purposes set out above or as required to comply with any legal obligations to which we are subject. This will involve us periodically reviewing our files to check that information is accurate, up-to-date and still required.

Where we are permitted to send you direct marketing communications we may retain your contact information necessary for this purpose, for as long as you do not unsubscribe from receiving the same from us. If you opt out from marketing, we will retain your information to enable us to respect your wishes to not be contacted for marketing purposes.

- 11. Security: We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.
- 12. Links to Other Sites: Our website may contain links to other sites, including via our social media buttons. While we try to link only to websites that share our high standards and respect for privacy, we are not responsible for the content, security, or privacy practices employed by other websites and a link does not constitute an endorsement of that website. Once you link to another website from our website you are subject to the terms and conditions of that website, including, but not limited to, its internet privacy policy and practices. Please check these policies before you submit any data to these websites.

- 14. How we use cookies: A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site.
